The wording of the motion was:

"This motion commits the attendees of this meeting to getting as many members as humanly possible to the next CFMEU Branch Meeting for a rally outside. We will invite the BIGs unions and all other supporters."

DUDC Statement on the High Court Decision

Defend the Unions - Defend the CFMEU condemns the High Court's decision to uphold the administration legislation passed by the Albanese Labor government and the Dutton-led opposition last year.

The High Court has given its blessing to the government silencing and straight-jacketing any union or member-based organisation based on untested allegations and mud-slinging by the media. The High Court has given its blessing to unionists being arbitrarily black banned from the industry for life without any right or recourse to defend themselves. It starts with the CFMEU, but it could be your union tomorrow.

In school, we are taught that the High Court will soberly assess cases on merit, and prevent government overreach and the erosion of civil liberties. In reality, the High Court does the bidding of the MBA and their lackeys in parliament.

When injustice becomes law, resistance becomes duty. When we stand together and strike, the working class has the power to overturn governments. The High Court might be happy to waive through laws that pave the way for authoritarianism in Australia. But we won't cop it.

Testing the limits

The High Court has sided with the political elite and the bosses, leaving no other legal challenge available to appeal the amendments to the Registered Organisations Act pushed through by the ALP and LNP last year.



Now, our organisers are about to test and be tested in the federal courts over the legalities of their sackings, demotions, and potential charges.

Esther Van Arend, OH&S Organiser, was sacked with no due process and no investigation in late November after going to a cinema and encountering journalist Nick McKenzie. They had words and by Monday morning McKenzie had already complained to the administration. Esther was sacked and put on a removed persons list, never allowed to represent workers or work for a union ever again.

Her first court hearing will be in the coming weeks or months. Her lawyers will argue that what was done was illegal and that she was unfairly dismissed. The case was supposed to be heard on the 24th of June but Mark Irving KC, the lead administrator, and his lawyers managed to cock it up and lodge it in the wrong courts...not bad for someone members are paying \$650k+ a year to pull apart the union and attack our organisers, like Esther.

Not only is Irving fighting for the wishes of McKenzie, he is also asking the courts to throw out Esther's case. He is using stand-over tactics and trying to drag it out, wasting members' money and costing Esther not just money but enormous stress. What Irving seeks to deny Esther is a protection held by every worker in the country (one against unfair dismissal), unless you work for or are a member of the CFMEU, apparently.

Joel Shackleton, aka Shaks, is the next cab off the rank. Shaks is a CFMEU organiser representing Vic members and heading up work in the union for First Nations workers; fighting against bosses committing fraud with black cladding.

This is when companies are set up to look like they are Indigenous-owned and managed but, in reality, are owned or managed by non-Indigenous people. They are happy to take advantage of procurement contracts with builders, especially on government projects.

The state government has initiatives to encourage principal contractors to to use Indigenous businesses on state government funded projects. While it is not a requirement that Indigenous businesses hire First Nations workers, it is more likely that they will.

While there is no government regulator, there are NGOs that certify Aboriginal businesses. But, bad actors have been finding ways to abuse this system. So, it's been up to Shaks and the rest of the CFMEU to hold the line and make sure members are getting a fair go. They ensure that companies aren't getting away with cashing in off the back of government initiatives and opportunities meant to help Indigenous workers.

Now the media are creating a frenzy over Shaks and, with allegations leveled against him, he will be taken to court mid-August in an attempt to silence and attack another great organiser that does their job with union values and a commitment to delivering for the members.

Queensland out the gate for 48!

On 19 June, the day after the High Court decision, CFMEU members across SE Queensland walked off the job and marched to the CFMEU office to protest the administration of our union. Each site held a vote on whether to stop work, and all votes were passed. Once at the office, workers voted to stay out for 48 hours. Work was stopped across Brisbane, Ipswich, Gold Coast, Logan, Scenic Rim, and Moreton Bay. Members shut down the Cross River Rail, Hutchinson's Queen St tower, and the Gold Coast Coomera Connector project.

Irving was terrified and threatened workers via text message. He has even gone so far as to advise the construction bosses that they should not pay workers who took action. Can it be any clearer which side he is on?!
