Skatteverket. Rättslig vägledning is a website developed by Skatteverket where employees and external users can find Skatteverkets interpretation of the law. The website is mainly used by employees but also, for example, banks. The website was in need of a refresh, having been designed over 10 years ago. I conducted user research together with a colleague and then proceeded on my own with designing the website. New functionality was added and old ones were replaced with Skatteverket's design system. The result: a more modern site with improved functionality. The new design is currently being implemented.
