- 1. Any bryophyte(s) fostered by me will be kept in a DNS-approved facility, until reintroduced back into a suitable home location. I understand that any bryophyte(s) I foster is/are the property of an other world, and I agree to rehome it immediately. I agree to bring any bryophyte(s) fostered by me to the suitable location by two weeks of the agreement. **I AGREE TO NOT ADOPT THE BRYOPHYTE**.
- 2. I agree to return the bryophyte(s) to the designated location within **2 weeks or 14 days** upon receiving the the bryophyte(s).
- 3. Any bryophytes(s) fostered by me will be fed, watered and exercised appropriately. I agree to provide an adequate and nutritious diet, including any necessary supplements, as recommended by DNS. I also agree to abide by any instructions given by DNS regarding the feeding.
- 4. I will not allow any foster bryophyte(s) to have any unsupervised, prolonged direct sunlight time. I will provide a damp area for their safety. I will not allow foster bryophyte(s) to go outside at anytime except to transport them to their suitable rehoming location.
- 5. I agree that bryophyte(s) will eventually be kept and remained in their suitable location unless otherwise discussed and approved by DNS.
- 6. I understand that DNS will take every precaution to ensure that any bryophyte(s) I foster are reasonably healthy and immediately rehomed. I understand that DNS cannot be held responsible for any unforeseen health problem that may develop after the bryophyte(s) is/are in my care.
- 7. I assume responsibility for any events that occur in connection with my fostering of a bryophytes for DNS. I AGREE TO NOTIFY A DNS REPRESENTATIVE IMMEDIATELY OF ANY ISSUES REHOMING THE MOSS.
- 8. I agree to keep my foster bryophyte(s) separate from any domestic beings not native to the bryophyte's original world.
- 9. I understand that the DNS cannot and does not make any representations or warranties, either expressed or implied concerning the temperament, habits, health, pedigree, disposition, age, sex or background of this bryophyte and that I have no right to a reimbursement of medical, adoption or other professional fees. Furthermore, I understand that the bryophyte's reactions to me, my family or any other person are completely unpredictable because bryophytes, like people, have their own personalities. I, as a foster caregiver, hereby release DNS from all claims of injury or damage that a fostered bryophyte may cause me or my property.
